September 27, 2017	Proxy mailing began.  Note: If approved, in advance of the reorganization, shareholders who participate in a systematic program will be notified to contact Federated to provide positive consent to establish these services in the new MDT Large Cap Value Fund.
October 20, 2017	New account set-up in <b>Clover Value Fund</b> and <b>MDT Large Cap Value Fund</b> will be restricted at the start of business.
November 6, 2017	Special shareholder meeting.
November 16, 2017	Last day for purchases, redemptions, transfers, and exchanges in <b>Clover Value Fund</b> and <b>MDT Large Cap Value Fund</b> , including via direct-to-Fund interfaces. Direct purchases and redemptions will be accepted.
November 17, 2017	The tax-free reorganization will be processed at the close of business in <b>Clover Value Fund</b> and <b>MDT Large Cap Value Fund</b> using a 4 decimal NAV; no purchases will be accepted. All redemptions, transfers and exchanges from either fund are restricted, including those via direct-to-Fund interfaces, and must be requested by calling the Client Service Team at 1-800-245-5051, option 1. <b>Conversion ratios will be provided after close of business as soon as they are available.</b>
